ARRIVAL DEADLINE

Shipments should arrive at the above address no later than **Monday, 24th February 2025**. Earlier arrival is recommended, however.

BOOKING COURIER SHIPPING

From within the EU: Shipments MUST be sent prepaid on a DAP basis (Delivered At Place).

From outside the EU: Shipments MUST be sent on prepaid, DDP basis (Delivered Duty Paid). **Uncleared shipments will not be accepted unless by prior arrangement. When booking, you must select "Duties & Taxes are for account shipper".**

IMPORTANT: Where the shipment is for an event such as this, there is no importer in Germany in whose name the shipment can be customs cleared. You must apply or already have been granted an "EORI" number, which is required for import into the EU. You can apply by completing and submitting the [EORI application form](#), Please note it can take 7 working days for applications to be processed and an EORI number issued. Please supply this number to the courier company and clearly show the number on the commercial invoice. You must also state "Incoterms: CIF"

For an EU shipment, please make sure that you do this prior to arrival.

For a non-EU shipment, by no later than **Monday 24th February 2025**.

Shipments arriving without prior order will be subject to a 50% late submission surcharge.

HANDLING CHARGES

The following charges for warehouse handling, interim storage and delivery to booth will apply:

Up to 50kgs/kgs. Vol*	€165.00 per shipment per air waybill (a volume/weight ratio of 3/1 applies)
Service Fee	€80.00 per shipment per master shipment ID
Courier Handover Fee	€50.00 per shipment per master shipment ID

* A further charge of €90.00 per each additional 25kgs/kgs. vol will apply.

Make sure your shipment's delivered DDP and duties/taxes are for account shipper! Our intervention and customs clearance charges will amount to €300.00 and 115% of duties & taxes in addition to the above and will not guarantee delivery.
